



अनुपालन हेतु आवश्यक निर्देश:-

1. छठे (6th) बैच एक्ट अप्रेंटिस प्रशिक्षण हेतु चयनित अभ्यर्थियों को यह मेरिट सह सत्यापन सूची प्रोविज़नल आधार पर जारी की गई है। रेलवे बोर्ड के दिनांक 06.10.2015 के पत्र संख्या- E(MPP)/2009/6/14 में निहित शर्त तथा रेलवे बोर्ड के समय समय पर प्राप्त हुए निर्देशों को ध्यान में रखते हुए तैयार किया गया है।
2. अभ्यर्थियों को अवगत कराया जाता है, कि यह प्रोविज़नल परिणाम सह सत्यापन सूची केवल प्रशिक्षण कराने हेतु जारी की जा रही है नौकरी देने का कोई प्रावधान इसमें नहीं है। प्रशिक्षण हेतु चयनित अभ्यर्थियों को केवल स्टाइपेन्ड दिया जायेगा।
3. प्रशिक्षण हेतु चयनित अभ्यर्थियों के चयन में, उनकी पात्रता संबंधी प्रारम्भिक जांच न करके अभ्यर्थी द्वारा दी गई जानकारी के आधार पर ही अग्रिम कार्यवाही की गई है। यदि किसी भी स्तर पर पात्रता में कोई कमी पाई जाती है तो उसी स्तर पर अभ्यर्थी की पात्रता/उम्मीदवारी समाप्त कर दी जायेगी। इसके अलावा अभ्यर्थी के विरुद्ध भारतीय दण्ड संहिता कि समुचित धाराओं के अंतर्गत/नियमानुसार अन्य कार्यवाही भी की जा सकती है। इसके लिए सम्पूर्ण जिम्मेदारी स्वयं अभ्यर्थी की ही होगी।
4. अभ्यर्थी द्वारा आवेदन पत्र के साथ संलग्न किए गए सारे प्रमाण- पत्रों की मूल प्रतियाँ सत्यापन के समय उपलब्ध होने चाहिए अन्यथा संबन्धित अभ्यर्थी की उम्मीदवारी निरस्त कर दी जायेगी।
5. प्रोविज़नल मेरिट सह सत्यापन की सूची आधुनिक रेल डिब्बा कारखाना, रायबरेली के वेबसाइट www.mcf.indianrailways.gov.in पर प्रकाशित की जा रही है। सत्यापन तिथियों में यदि अभ्यर्थी अनुपस्थित होते हैं तो ऐसे अभ्यर्थी की अभ्यर्थिता निरस्त कर दी जायेगी। रेलवे बोर्ड के पत्रांक E(MPP)/2009/6/14 दिनांक: 06.10.2015 (RBE No. 120/2015) के पैरा 4.B (iv) के अनुसार प्रोसेसिंग शुल्क के तौर पर प्रमाणपत्रों के सत्यापन के समय रु. 100/- (एक सौ रुपया मात्र) का पोस्टल ऑर्डर/डिमाण्ड ड्राफ्ट जो 'PFA/MCF/RBL' Payable at Lalganj के नाम से देय होगा लाना अनिवार्य है। यह प्रोसेसिंग शुल्क अनुसूचित जाति/अनुसूचित जनजाति/शारिरिक रुप से विकलांग एवं महिला उम्मीदवारों द्वारा भुगतान किया जाना अपेक्षित नहीं है।
6. अधिकांश अभ्यर्थियों ने जाति प्रमाण पत्र संबन्धित राज्य द्वारा जारी प्रारूप में उपलब्ध कराये हैं ऐसे सभी अभ्यर्थियों को निर्देशित किया जाता है कि प्रमाण पत्रों के सत्यापन के समय जाति प्रमाण पत्र संलग्नक H एवं I के प्रारूप में लेकर आना सुनिश्चित करें।
