Please refer to Board's letter No. PC-VII/2017/R-1/7 dated 18.12.2019 (RBE No. 212/2019) forwarding therewith Ministry of Finance/Department of Expenditure's O.M. No. 4-21/2017-IC/E.IIIA dated 28.11.2019 *inter-alia* providing clarification on Date of Next Increment under Rule 10 of Central Civil Services (Revised Pay) Rules, 2016 for adoption of the same in Railways with respect to Railway Services (Revised Pay) Rules, 2016.


2. Ministry of Finance/Department of Expenditure vide para 7 of their O.M. dated 28.11.2019 also approved that the employees who have been regularly promoted or granted financial upgradation on or after 01.01.2016 and desire to exercise/re-exercise option for pay fixation under FR22(I)(a)(1) shall be given an opportunity to exercise or re-exercise option there under and such an option shall be exercised within one month of issue of their O.M.

3. Now, Ministry of Finance/Department of Expenditure vide their another O.M. No. 04-21/2017-IC/E.IIIA dated 15.04.2021 (copy enclosed) partially modified para 7 of their O.M. dated 28.11.2019 and approved for allowing another opportunity to Government employees to exercise/re-exercise option for pay fixation as allowed under their O.M. dated 28.11.2019.

4. The aforesaid O.M. dated 15.04.2021 of Ministry of Finance/Department of Expenditure shall be applicable *mutatis mutandis* in Railways too with respect to Railway Services (Revised Pay) Rules, 2016.

5. The 'three months' period mentioned in para 2 of aforesaid O.M. dated 15.04.2021 of Ministry of Finance/Department of Expenditure shall be three months from the date of issue of these instructions.

OFFICE MEMORANDUM

Subject- Date of next increment under Rule 10 of Central Civil Services (Revised Pay) Rules, 2016 - Clarifications - regarding

The undersigned is directed to invite attention to this Department's O.M. of even No. dated 28<sup>th</sup> November, 2019 on the subject noted above. In the said O.M. dated 28.11.2019, in para '7', the employees who have been regularly promoted or granted financial up-gradation on or after 01.01.2016 and desire to exercise/re-exercise option for pay fixation under FR 22(1)(a)(i) were given an opportunity to exercise or re-exercise of their option for pay fixation within one month of the date of issue of the said O.M. dated 28.11.2019. However, a large number of references have been received in this Department seeking condonation of delay and allowing another opportunity to exercise/re-exercise the option for pay fixation as allowed under O.M. dated 28.11.2019 as the employees have faced time constraint, etc. in exercising their option for pay fixation thereunder.

2. The issue has been examined in this Department and the Competent Authority in partial modification of the conditions enumerated in para '7' of the said O.M. has approved for allowing another opportunity to Government employees to exercise/re-exercise option for pay fixation as allowed under O.M. dated 28.11.2019 within three months from the date of issue of this Office Memorandum. No further request for extension of date or relaxation of condition in exercising of option will be entertained under any circumstances.
3. All other conditions of O.M. dated 28.11.2019 remain unchanged.
4. In their application to the persons belonging to Indian Audit and Accounts Department, these orders are issued under Article 148(5) of the Constitution and after consultation with the Comptroller and Auditor General of India .

विषय: केन्द्रीय सिविल सेवा (संशोधित वेतन) नियमावली, 2016 के नियम 10 के तहत अगली वेतनवृद्धि की तारीख के स्पष्टीकरण के संबंध में।

अधीनस्थकारी को उपर्युक्त विषय पर इस विभाग के दिनांक 28 नवंबर, 2019 के समसहयक का.जा. की ओर ध्यान आकृष्ट करने का निर्देश हुआ है। दिनांक 28.11.2019 के उक्त का.जा. के पैरा '7' में जित्त कर्मचारियों को दिनांक 01.01.2016 को या इसके बाद नियमित पदोन्नति या वित्तीय उन्नयन प्रदान किया गया है तथा जो मूल नियम 22(1)(क)(i) के तहत वेतन निर्धारण के लिए विकल्प का प्रयोग/पुनः प्रयोग करना चाहते हैं, को दिनांक 28.11.2019 के उक्त का.जा. के जारी होने की तारीख से एक माह के भीतर वेतन निर्धारण के लिए अपने विकल्प का प्रयोग या पुनः प्रयोग करने का अवसर दिया गया था। तथापि, इस विभाग में दिनांक 28.11.2019 के का.जा. में दी गई अनुमति के अनुसार वेतन निर्धारण के लिए विकल्प का प्रयोग/पुनः प्रयोग करने में हुए विलंब को माफ करने तथा एक और अवसर प्रदान करने के लिए बड़ी संख्या में अभ्यावेदन प्राप्त हुए हैं क्योंकि कर्मचारी इसमें उल्लिखित वेतन निर्धारण हेतु समय की बाधयता आदि के कारण अपने विकल्प का प्रयोग नहीं कर पा रहे हैं।

2. इस मामले पर इस विभाग में विचार किया गया है और सक्षम प्राधिकारी ने उक्त का.जा. के पैरा 7 में उल्लिखित शर्तों में आशिक संशोधन करते हुए, जैसा कि सरकारी कर्मचारियों को दिनांक 28.11.2019 के का.जा. के तहत अनुमति प्रदान की गई थी, के अनुसार इस कार्यालय जापन के जारी होने की तारीख से तीन माह के भीतर वेतन निर्धारण के लिए विकल्प का प्रयोग/पुनः प्रयोग करने का एक और अवसर प्रदान करने की अनुमति दे दी है। अविष्य में किसी भी परिस्थिति में विकल्प के प्रयोग हेतु तारीख बढ़ाने या शर्तों में छूट देने संबंधी किसी भी अनुरोध पर विचार नहीं किया जाएगा।

3. दिनांक 28.11.2019 के का.जा. की अन्य सभी शर्तें अपरिवर्तित रहेंगी।

4. भारतीय लेखापरीक्षा और लेखा विभाग में कार्यरत कर्मचारियों पर इसकी प्रयोज्यता के संबंध में, ये आदेश नविधान के अनुच्छेद 148(5) के तहत तथा भारत के नियंत्रक और महालेखापरीक्षक के परामर्श से जारी किए जाते हैं।
