





Date, Time & Venue of Walk-in-interview & Medical Examination:-

Date, Time & Venue of Walk-in-interview will be as under. Medical examination of the selected candidates will be held after the Walk-in-interview on a date to be intimated on the day of interview:

Date of Walk-in-Interview : 01.12.2022.
Reporting Time : 09:00 Hrs. to 14:00 Hrs.
Interview (start time) : From 15:00 Hrs. onwards.
Venue : Personnel Department, MCF, Lalganj, Raebareli.

Candidates are advised to report for Walk-in-Interview on 01.12.2022 from 09:00 Hrs. to 14:00 Hrs. alongwith duly filled & signed application in the prescribed Proforma (Annexure-I) and self-attested copies of certificates to SPO/Gaz. for verification of documents, etc. **The candidates reporting after the scheduled time shall not be allowed to appear in the interview.**

Remuneration:

Consolidated remuneration at the rate of Rs. 75,000/- for General Duty Doctors per month will be admissible, if Govt. accommodation is not provided. If Govt. accommodation is provided an amount equivalent to House Rent Allowance payable to a fresh entrant to Group 'A' Jr. Scale and License fee of Railway accommodation so provided shall be deducted from the monthly remuneration payable to the CMP.

Remuneration for retired Railway Doctors & Central/State Govt. Retired Doctors:

Consolidated remuneration at the rate of Rs. 46,000/- per month will be admissible (subject to the condition that remuneration plus pension drawn should not exceed the last pay drawn), if Govt. accommodation is not provided. If Govt. accommodation is provided an amount equivalent to House Rent Allowance payable to a fresh entrant to Group 'A' Jr. Scale and License fee of Railway accommodation so provided shall be deducted from the monthly remuneration payable to the CMP.

Age limits:

Candidates should not have completed more than 50 years of age as on **01.12.2022.** However, age relaxation of 05 years for SC/ST and 03 years for OBC candidates is admissible.

Age for Retired Railway Doctors and Central/State Govt. Retired Doctors:

Candidates should not have completed more than 63 years & 06 months of age as on **01.12.2022.**

Terms & Conditions:

Engagement of doctors would be on contract basis initially for a period of one year on annual basis. Period of contract is not extendable on any grounds. However, the Railway Administration shall reserve the right to enter into fresh contract with the Medical Practitioner for another term. Further, services of these doctors can be terminated even before the expiry of one year after giving 15 days notice on either side. Railway administration reserves the right to terminate the contract at any time during the contract by giving 15 days notice or payment of 15 days remuneration without assigning any reason whatsoever. The services rendered as contract doctor is a stop gap arrangement and will not be taken into consideration in case of their selection through UPSC. It will also not confer upon them any right for regularization or permanent absorption in the Railways. The engagement shall purely be on contract basis for a period of one year or till the regular incumbent joins or on Retired Railway Doctors & Central/State Govt. Retired Doctors attaining the age of 65 years, whichever is earlier. Contract is liable to be terminated, if the CMP is found to be mentally or physically incapacitated.

Terms & Conditions for Retired Railway Doctors and Central/State Govt. Retired Doctors:

Engagement of Retired Railway Doctors & Central/State Govt. Retired Doctors as CMPs shall be for a maximum of 05(five) years. The contract shall be entered into for a period of one year or less from the date of entering into the contract subject to completion of 65 years of age. The engagement shall purely be on contract basis for a period of one year or till a regular incumbent joins or on the Retired Railway Doctors & Central/State Govt. Retired Doctors attaining the age of 65 years, whichever is earliest. The Retired Railway Doctor & Central/State Govt. Retired Doctor engaged as CMP shall not have any claim or right for his/her continuity in service or automatic extension of the term of contract. During the validity of the contract, the CMP shall be at liberty to terminate on any ground by giving 15 days notice to the Railways. Railway Administration reserves the right to terminate the contract at any time during the contract by giving 15 days notice or payment of 15 days remuneration without assigning any reason whatsoever. Contract is liable to be terminated, if the CMP is found to be mentally or physically incapacitated.

Essential Educational Qualifications:

GDMOs: MBBS from a recognized University and must have completed one year rotating internship and should be in possession of valid Registration Certificate issued by any of the State Medical Councils/Medical Council of India.

Experience

GDMOs: For General Duty Doctors, candidates with experience will be given preference.

Criteria for Evaluation:

Maximum marks for evaluation will be 100.



Note:

- (i) **Preference will be given in engagement to Retired Railway Doctors followed by Retired State/Central Government and then candidates from open market.**
- (ii) The candidate will give a self declaration stating that they are not suffering from any chronic disease or comorbidity that will put at increased risk in a situation where they have to deal with unscreened patients.
- (iii) The doctors so engaged on contract basis will not be allowed private practice.
- (iv) The contract doctors shall not be entitled for Railway Quarter as a matter of right.
- (v) Candidates should bring their application form alongwith original and attested copies of all certificates and mark-sheets at the time of interview. No TA/DA is admissible.
- (vi) The offer of engagement to the selected candidates shall be issued subject to the availability of vacancy as per requirement in MCF/RBL Hospital. **Administration reserves the right to change the number of posts/vacancies as per administrative needs.**
