1. चौथा (4th) बैच एक्ट अप्रेंटिस प्रशिक्षण हेतु चयनित अभ्यर्थियों को यह मेरिट सह सत्यापन सूची प्रोविजनल आधार पर जारी की गई है। रेलवे बोर्ड के दिनांक 06.10.2015 के पत्र संख्या- E(MPP)/2009/6/14 में निहित शर्त तथा रेलवे बोर्ड के समय समय पर प्राप्त हुए निर्देशों को ध्यान में रखते हुए तैयार किया गया है।

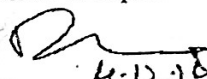

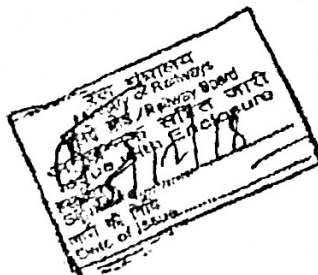
