It has been decided to hold a selection for forming a panel of 01 (UR=01, SC=00, ST=00 & PwBD=00) nos. of post of JE/CIVIL/PQ/25% in Pay Matrix, Level-6 (GP-4200/-) against Departmental Promotion Quota in Civil Department.

No. of Posts: 01 (UR=01, SC=00, ST=00 & PwBD=00)

1. Staff in category/grade of Sr. Technician in pay Level-6, GP-4200/- working in Civil Department with 02 years of regular service on the date of notification are eligible for above selection on order of seniority. If Sr. Technicians in pay Level-6, GP-4200/- are unwilling to seek promotion in this selection, or requisite number of eligible Sr. Technicians are no available, then Tech-I in Pay Level-5, GP-2800/- who have completed two years regular service, will be considered eligible for above selection in order of seniority. Senior most candidates will be called for selection on 1:3 formula as per inter-se-seniority amongst the candidate, who will opt to appear in the selection.

Note :-

Master Circular-31 Para-7.1 (C): The conditions of two years minimum service has to be satisfied at the time of actual promotion. Thus, in the case of a Selection Post, all employees who are regular in the relevant lower grade and come in the zone of consideration according to 3x formula can be considered according to the procedure laid down for selection but a person, who is empanelled, can actually be promoted only when he completes two years service in the immediate lower grade.



02. The list of probable candidate coming under zone of consideration is included as main list "A" in Annexure-1. In case any of the candidate has objection in the eligibility list, the same may be reported on this office within 15 days from the date of issue of this notification.
03. The willingness/unwillingness to appear in the above selection must be submitted by 13.09.2023 to the undersigned in the prescribed proforma enclosed as Annexure-II in case unwillingness of some of the employees listed in Annexure-I to appear in the subject selection is received, a second list "B" of eligible employees will be issued calling for willingness to make up the short fall of eligible candidates as per 1:3 formula.
04. Empanelled candidates in the above written selection will be required to undergo medical examination, if required and will have to undergo training for a period of 26 weeks as prescribed for DP Quota at TTC, which is mandatory, failing which name will be deleted from the panel. During the training period they will get the salary/stipend as admissible under extant rules. {Authority: Rly. Board's L.No. E(MPP)-2019/3/46 dated 28.10.2019 (RBE No. 183/2019)}
05. Candidates who will pass in the final examination after the above training will be promoted as JE/Civil in Pay level-6 (GP-4200/-) and posted against working posts as per vacancy.
06. Examination will be held in the form in written test. The time of written examination will be 120 minutes and all the question will be of objective type, out of which 10% questions will be from the Rajbhasha. There shall be no negative marking for incorrect answer. There will be supplementary examination for those who fail to appear in the written examination for valid reasons and circumstances beyond their control. Such candidates will have to submit application within three days of the written examination with documentary evidence. Their candidature for supplementary examination will be decided by the competent authority on merit of the case. {Authority: Rly Board's Letter No. E(NG)I-2018/PM1/4 dated 14.12.2018 (RBE No. 196/2018), L. No.E(NG)I-2018/PM1/4 dated 14.06.2019 (RBE No. 97/2019), L.No. E(NG)I-2018/PM1/4 dated 14.11.2019 (RBE No. 194/2019) & Master Circular-31 Para-7.3}
07. Above Selection will comprise of written examination followed by scrutiny of service record and APARs of the candidate who will qualify in the written test. The candidate must secure 60% of marks in professional ability as well as in the aggregate. There is no reserve post of SC/ST, so no relaxation in qualifying marks for candidate belonging to SC/ST community will be allowed. They have to obtain minimum of 60%in written test and 60% in aggregate on par with UR employees for empanelment against UR vacancies. The panel will be formed strictly in order of seniority. (Authority: Master Circular-31 Para-8)
08. The date, venue and time of written examination will be intimated separately. All the willing candidate are advised to keep themselves in readiness to appear in the written test at a short notice.
09. The syllabus of the written examination for this selection is enclosed herewith as per Annexure-III.
10. The Incharge/Controlling Officers of the candidates listed in Annexure-I are requested to circulate the notification for wide publicity amongst the staff working under their administrative control.
