(DRQ Level-7) in Mechanical Department on re-engagement of retired Railway staff on contractual basis.

2. His re-engagement is temporary and shall not be considered as a case of re-employment.
3. His re-engagement will be initially for a period of **ONE** year. However, Railway administration shall reserve the right for fresh re-engagement for another term.
4. The period of re-engagement may be further extended based on administrative requirement. The maximum extension may be considered till 14.10.2026, i.e. the date of validity of scheme.
5. He shall be discharged immediately on joining of selected candidates from RRB or through departmental selection as per the recommendation of PHOD/CHOD concerned.
6. He will be paid a fixed monthly remuneration, which will be fixed by deducting the Basic Pension from the Pay drawn at the time of retirement.
7. The remuneration so fixed shall remain unchanged for the term of the contract. Annual increment/percentage increase and Dearness Allowance shall NOT be allowed during the contract period.
8. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed nor carried forward in





case the engagement is extended. Also, no payment in lieu of unutilized leaves will be paid at the time of discharge/expiry of the control.

9. He will not be entitled to HRA and residential accommodation. However, Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed, not exceeding the rate applicable at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment.

10. He will be allowed TA/DA for official tour, if any, as per their entitlement at the time of retirement.

11. The monthly remuneration will be as per the Railway Board's letter dated 15.10.2024. This will be subject to any future instructions issued by the Railway Board on the matter.

12. He will not be paid any travelling expenses by this office for joining the post.

13. His re-engagement will be governed by the rules/regulations and terms & conditions in vogue and issued from time to time by Railway Board.

14. The re-engagement is purely on temporary basis and the staff will be discharged as & when suitable regular incumbents joined the post either by way of recruitment or by transfer or on attaining the age of 65 years whichever is earlier or on cessation of the scheme or due to surrender of post or due to manpower planning or administration does not require the services.

15. The above-mentioned Re-engaged staff should report to the designated posting location and submitted the charge assumption report to this office.
