The promotions ordered in favour of the above employees are subject to the following conditions:

1. The promotion of the above employees will take effect from the date they assume higher responsibilities.
2. The employees promoted above shall carry out their promotion within 15 (Fifteen) days from the receipt of this order and failure to do will be



- treated as refusal of promotion and consequently they will not be eligible to be considered for promotion before the expiry of one year debarment period and they will lose seniority to all their juniors promoted in the meanwhile.
3. The promotion is ordered on the condition that there are no prima facie cases pending against them as a result of fact finding enquiry or otherwise and that they have not been placed under suspension or no departmental proceedings have been initiated against them or there are no proposal to initiate proceedings at a later date or they are not undergoing any penalty debarring them from promotion.
  4. The promotees are allowed to exercise option within a period of one month from the date of assuming higher responsibilities under Rule 1313(FR-22)(1)(a)(i) of R.II
    - a) From the date of promotion or
    - b) From the date of next increment viz. 1st July of the year. In case the railway servant opts to get them pay fixed from their date of next increment then, on the date of promotion, Pay in the Pay Matrix Level shall continue unchanged, but the grade pay of the post will be granted. Further re-fixation will be done on the date of their next increment i.e. 1st July. This is in accordance with clarification No.2 of Railway Board's letter No. PC.V/2008/RSRP/1 dated 25.09.2008 (PC-VII/22, RB No.132/2008).
  5. The employees already drawing higher Grade Pay due to MACP are not eligible for any fixation benefits since the same has been granted during their financial upgradation. In case an employees do not exercise any option within one month from the date of issue of this Office Orders, it may be noted that their pay will be fixed as 4(a) above.
  6. The promotion ordered is purely provisional subject to the outcome of the cases pending in various courts on SC/ST reservation.
  7. The date of taking up independent duty of the above named employees may be advised to all concerned with reference to this office order.
  8. The employees who are under orders of transfer should vacate Railway Quarters immediately on relief if any occupied by them. If they propose to retain the quarters as per extant orders, they should apply in time for retention and obtain prior permission. Retention of Railway quarters without/ beyond permissible months will attract deduction of damaged rate of rent.
  9. Any excess payment found to have been made in regard to this order is required to be refunded when detected later by Railways.
